PACE Background

In 2012, New Jersey passed legislation enabling Property Assessed Clean Energy or "PACE", a game-changing financing model for energy retrofits and renewable energy systems. Up to 100% financing is made available for approved commercial, industrial, and nonprofit projects and repaid according to the terms of a Special Clean Energy Assessment (which is similar to a sewer or sidewalk assessment, only voluntary), and registered with the municipality.
